The Board wishes to inform the shareholders of the Company and potential investors that based on information currently available, the Group is expected to record a loss for the three months ended 30 June 2013 and an increase in loss as compared with the corresponding period in 2012, mainly because (i) Qinghai Baike had contributed profit of HK\$3,369,000 to the Group for the three months ended 30 June 2012 but the Group has disposed of Qinghai Baike in November 2012 and Qinghai Baike ceased to contribute profit to the Group; and (ii) the revenue for the three months ended 30 June 2013 has decreased by reason of the fierce competition in the PRC for the implementation of self-service ATM systems and printing systems.

The information contained in this announcement is only based on the preliminary assessment by the management of the Company of the unaudited consolidated management accounts of the Group for the three months ended 30 June 2013 and is not based on any figure or information which has been audited or reviewed by the Company's auditors.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.

The board of directors (the “**Board**”) of China Technology Solar Power Holdings Limited (the “**Company**”) and together with its subsidiaries, the “**Group**”) wishes to inform the shareholders of the Company and potential investors that, based on information currently available, the Group is expected to record a loss for the three months ended 30 June 2013 and an increase in loss as compared with the corresponding period in 2012, mainly because (i) Qinghai Baike Solar Power Co., Ltd.* (青海百科光電有限責任公司) (“**Qinghai Baike**”) had contributed profit of HK\$3,369,000 to the Group for the three months ended 30 June 2012 but the Group has disposed of Qinghai Baike in November 2012 and Qinghai Baike ceased to contribute profit to the Group; and (ii) the revenue for the three months ended 30 June 2013 has decreased by reason of the fierce competition in the People’s Republic of China (“**PRC**”) for the implementation of self-service ATM systems and printing systems.
